

Terms and conditions of the „Support a charitable cause with Finax“ campaign

Finax, o.c.p., a. s., with its registered office at Bajkalská 19B, Bratislava – Ružinov 821 01, Slovakia, registered in the Commercial Register of the Bratislava III District Court, Section Sa, File No. 6713/B (hereinafter referred to as “Finax”), hereby sets out the terms and conditions governing participation in the “Support a Charitable Cause with Finax” Campaign (the “Campaign”). Participation in the Campaign is subject to fulfilling the conditions specified in these Terms and Conditions.

1. Campaign Description and Participation Conditions

- a) The Campaign begins on 13 July 2026 and will continue until the campaign target is reached, namely raising PLN 100,000 (one hundred thousand Polish zloty) for Fundacja Dajemy Dzieciom Siłę.
- b) The Campaign is open to existing Finax clients who hold an active account. If a person referred by a participating client registers through the client’s personal referral link, opens an account, and successfully activates it by completing Finax’s verification process, Finax will donate PLN 100 (one hundred Polish zloty) to Fundacja Dajemy Dzieciom Siłę to support the foundation’s statutory activities.
- c) The Campaign partner is Fundacja Dajemy Dzieciom Siłę.
- d) Donations made under the Campaign will be allocated to the Dziecko w Sieci project, which funds psychological support services, including counselling and therapy, for children who have experienced violence, abuse, or harmful online behaviour.
- e) Upon fulfilling the conditions set out in section b above, the referring client participates in the Campaign by supporting the activities of Fundacja Dajemy Dzieciom Siłę. The referring client is not entitled to any cash reward, management fee discount, or other benefit in connection with a successful referral. The client receives no financial advantage and participates solely as part of the charitable initiative. At the same time, every referred person who meets the Campaign conditions will receive the standard Finax referral benefit: portfolio management free of charge on investments of up to €2,000 for a period of three years, in accordance with the applicable Finax referral program rules.
- f) Only clients with an active Finax account may refer friends. There is no limit to the number of referrals that may be made.
- g) The referred person’s benefit, consisting of portfolio management free of charge on investments of up to €2,000 for three years, remains valid for three years from the date of account activation or until the first withdrawal is made from the Finax account by the referred client, whichever occurs first.

2. Campaign Execution:

For each new client who fulfils the conditions set out in these Terms and Conditions, Finax will donate PLN 100 (one hundred Polish zloty) to Fundacja Dajemy Dzieciom Siłę until the Campaign goal of PLN 100,000 (one hundred thousand Polish zloty) has been reached, representing approximately 1,000 successful referrals.

Campaign progress will be published on the Finax website and updated at least once per month.

3. Final Provisions

Finax reserves the right to amend these Terms and Conditions or terminate the Campaign at any time. Information regarding any amendments or the termination of the Campaign will be published on www.finax.pl and will also be available at Finax's registered office.
