Procedures performed

In order to issue this confirmation, we have performed the following procedures:

- The company Finax, o.c.p., a. s. provided us with a list of client accounts showing the value of client assets broken down into cash and securities held in Capitol system as at December 31st, 2021. We reconciled a sample of the asset accounts with the balances recorded in the Capitol system as at December 31st, 2021;
- We traced the total value of securities to a statement from the custodian Linear Investments Limited as at December 31st, 2021;
- We traced cash to a statement from the custodian Linear Investments Limited, resp. to the final balance on bank statement as at December 31st, 2021.
