

## **PUBLIC PROMISE**

### **For a 100% discount on the insurance price in 2021**

The company Finax, o.c.p., a.s., with its registered seat at Bajkalská 19B, 821 01 Bratislava-mestská časť Ružinov, identification number (IČO): 51 306 727, registered in the Business Register of the District Court Bratislava I, in section Sa, in insert number 6713/B (hereinafter referred to as "Finax") in accordance with § 850 et seq. of Act no. 40/1964 of The Civil Code, as amended, addresses a public promise for a 100% discount on the total price of insurance for 2021 (hereinafter referred to as the "discount") to clients, provided that all the conditions stated in this promise are met:

#### **Discount conditions:**

- a) the client must have opened an account in Finax and has undergone proper verification and meets the conditions for inclusion in the insurance,
- b) the client expresses an agreement to join the insurance in accordance with the contractual documentation in the period from 1.9. to 30.11.2021,
- c) within 30 days of joining the insurance, the client pays the total price of the insurance (i.e. the insurance premium and the fee) determined according to the price list of insurance for 2022,
- d) the insurance will not be terminated by the client (eg. by withdrawal, termination, expiration of the contractual relationship) and the client remains insured for the calendar year 2022.

#### **Application of the discount:**

A client who meets the conditions set out in this promise receives a 100% discount on the total price of insurance (insurance premium and fee) for the year 2021 as follows:

- Clients who register in the period from 1.-30.9.2021 and meet the conditions specified in this promise will become insured from 1.10.2021 and will be insured for 3 months free of charge (i.e. they receive a 100% discount on the insurance price (insurance premium and fee) for the period from 1.10.2021 to 31.12.2021)
- Clients who register in the period from 1.-31.10.2021 and meet the conditions specified in this promise will become insured from 1.11.2021 and will be insured for 2 months free of charge (i.e. they receive a 100% discount on the insurance price (insurance premium and fee) for the period from 1.11.2021 to 31.12.2021)
- Clients who register in the period from 1.-30.9.2021 and meet the conditions specified in this promise will become insured from 1.12.2021 and will be insured for 1 month free of charge (i.e. they receive a 100% discount on the insurance price (insurance premium and fee) for the period from 1.12.2021 to 31.12.2021)

Finax reserves the right to refuse to grant the discount or to cancel it later if the client has not met or ceases to meet the conditions stated above, as well as if the client withdraws from the insurance or the insurance is terminated or halted for any reason.
